1. CONTROLLER

As the controller of this XING page, we (ifm statmath gmbh) are jointly responsible with the controller of the social network XING (NEW WORK SE), we are the controller within the meaning of Art. 4 No. 7 of the General Data Protection Regulation (GDPR). When you visit our XING page, personal data is processed by the controllers. In the following, we will inform you about what data is involved, how it is processed and what rights you have in this regard. As the controller of this page, we have entered into agreements with XING, which, among other things, regulate the conditions for using the XING page. regulate. The terms of use of XING and the other conditions and guidelines listed at the other conditions and guidelines listed at the end.

2. USE OF INSIGHTS AND COOKIES

In connection with the operation of this XING page, we use XING's Insights function to obtain anonymised statistical data on the users of our XING page. For this purpose, XING stores a cookie on the end device of the user who visits our XING page. Session cookies only remain on your device until you stop browsing. Persistent cookies remain on your computer or mobile device until they expire or are deleted. The information stored in the cookies is received, recorded and processed by XING, in particular when the user uses the XING services, services provided by other members of the NEW WORK SE group of companies and services provided by other companies that use the XING services. In addition, other entities such as NEW WORK SE partners or even third parties may use cookies on the XING services to provide services to companies advertising on XING. You can find more information on the use of cookies by XING in their Cookie Policy.

3. PURPOSES OF THE PROCESSING

The processing of the information is intended, among other things, to enable XING to improve its improve the advertising system that it distributes via its network. On the other hand, it should enable us as the operator of the XING page to obtain statistics that XING creates based on visits to our XING page. This aims to control the marketing of our activities. For example, it is For example, this enables us to gain knowledge of the profiles of visitors who like our XING page or use applications on the page in order to provide them with more

provide them with more relevant content and develop features that may be of greater interest to them. may be of greater interest to them.

To help us understand how we can better achieve our goals with our XING page our goals with our XING page, the information we collect is also used to demographic and geographical analyses are also created and made available to us.

made available to us. We can use this information to place targeted interest-based adverts without obtaining direct knowledge of the identity of the visitor. the identity of the visitor. If visitors use XING on several end devices devices, the data can also be collected and analysed across devices, if the visitors are registered and logged into their own profile. in their own profile. The visitor statistics generated are only transmitted to us in anonymised form. transmitted to us. We have no access to the underlying data.

4. LEGAL BASIS AND LEGITIMATE INTERESTS

We operate this XING page in order to present ourselves to XING users and other interested persons who visit our XING page and to communicate with them. The processing of users' personal data is carried out on the basis of our

legitimate interest in an optimised bank presentation (Art. 6 para. 1 lit. f GDPR).

5. TRANSFER OF DATA

It is conceivable that some of the information collected may also be processed outside the European Union by NEW WORK SE based in Germany. NEW WORK SE is certified under EU data protection agreements and thus undertakes to comply with the European data protection requirements in accordance with the EU standard data protection clauses pursuant to Art. 46 EU GDPR. We do not pass on any personal data ourselves.

6. OPTIONS TO OBJECT

XING users can use the settings for advertising preferences to influence the extent to which their user behaviour may be recorded when they visit our Instagram page. The XING settings offer further options.

The processing of information by means of the cookies used by XING can also be prevented by not allowing cookies from third-party providers or those from XING in your own browser settings.

7. NATURE OF JOINT CONTROLLERSHIP

The agreements with XING, including on joint controllership, essentially mean that requests for information and the assertion of other data subject rights should be made directly to XING.

rights of data subjects should be asserted directly with XING. As the provider of the social network and the possibility of integrating XING pages there, XING alone has direct access to the necessary information and can also immediately take any necessary measures and provide information.
